Diving Ireland now offers a short-term 30-day Full Diver membership at a reduced cost to facilitate *guest divers*' participation in Diving Ireland events such as Dive Rallies. The Membership includes Diving Ireland Insurance cover, while ensuring Diving Ireland protocols and standards are complied with.

## Benefits

- The duration of the short-term membership is 30 days from the member registration date on JustGo
- The reduced cost of the 30-day membership is €50 (vs €130 for the annual membership)
- The short-term membership option is only available for Full Diver memberships
- Sports covered: Scuba diving.
- Diving Ireland Insurance: The short-term full diver membership includes insurance cover for:
  - Personal Injury Insurance (Group Injury Policy)
  - Liability Insurance (Combined Liability Policy)
  - Instructor Liability Insurance (Professional Indemnity Policy)provided activities are undertaken in full compliance with [Diving Ireland Training and Standards](#).
  - For more details, search for the term '*Insurance*' in the "Documents" tile on JustGo for the insurance documents for this year.
- Membership can be upgraded to "Full Diver" annual membership through payment of an additional €100, if upgraded within 30 days of expiry of short-term membership
- The short-term membership can only be availed of for *one* 30-day period in any one year. In other words, you cannot renew a 30-day membership until next year.

## Requirements

- The Applicant must apply for membership of, and be accepted by, an affiliated Diving Ireland subaqua club.
- The Applicant must comply fully with Diving Ireland Training & Standards. See [DI 401 TRAINING AND STANDARDS MANUAL](#)
- The Applicant must upload existing diving qualifications to their JustGo profile and have them 'recognised' by their Club DO before diving with Diving Ireland. Prospective short-term members must engage with their 'accepting' club with regard to any club registration or membership terms, conditions or costs which are separate from this Diving Ireland Short-Term membership.
- Short-Term Diving Ireland members are subject to the same criteria with regard to dive readiness and active diver status as full members. In particular, short-term members are required to:
  - Complete a **Medical Disclaimer**, via JustGo
  - Complete or provide documentary evidence of completion of the prescribed **Fitness Test** to the satisfaction of the Club Diving Officer (DO)
  - Provide evidence of **Active Diver Status** by way of a current dive log to the satisfaction of the Club DO
  - Apply for a **Recognition Credential** for a relevant non-Diving Ireland certifications as recognised in DI 403 Diver Equivalency Application & Guide and have the same approved by the Club DO. Such recognition, fitness test and active diver status must be formally approved by Club DO on JustGo platform prior to any diving activity
- Short-Term members are required to abide by the Diving Ireland Codes of Conduct and comply fully with DI 401 Training & Standards, including all Rules & Recommendations.
- Short-Term members must hold a Diving Ireland recognised diving qualification as recognised under the Diving Ireland Equivalence and Recognition policy IUC 403.
- Short-Term members are not permitted to engage in any training, assessment or instructional activities.
- Short-Term members may not dive as a 'buddy' with any DI grade below D\*\*, i.e. no diving with D\* or novice divers.
- Short-Term members must only dive within the parameters of their existing diving qualifications and subject to the primacy of DI Training & Standards DI 401 parameters.
- Conversion to full time membership at cost of €100 is contingent on the applicant complying with and completing the Diving Ireland equivalence protocols IUC 403 and being issued a Diving Ireland certification – the cost of such certification is €30.
- Short-Term members are subject to Diving Ireland Disciplinary Regulations IUC 304 for any breaches of the terms of membership.

## Frequently Asked Questions (FAQs)

- *Q: Why is Diving Ireland introducing a short-term membership?*
- A: Diving Ireland is introducing the short-term membership to facilitate a revised Diving Ireland Guest Diver Policy including visiting divers who wish to attend DI approved events including Dive Rally events. The intention is not to be overly restrictive while ensuring DI protocols and standards are complied with and appropriate Diving Ireland insurance cover applies. We also aim to ensure that any short-term membership or guest policy is complementary and consistent with the terms of Full-Diver membership including medical disclaimer, insurance or requirements for active diver status.
  
- *Q: How much is the short-term membership?*
- A: The reduced cost of the short-term membership is €50 (vs €130 for the annual membership)
  
- *Q: How long is the short-term membership for?*
- A: The duration of the short-term membership is 30 days from the member registration date on JustGo
  
- *Q: Does it include full Insurance?*
- A: Yes. Provided activities are undertaken in full compliance with Diving Ireland Training and Standards, the short-term full diver membership includes insurance cover for Personal Injury Insurance (Group Injury Policy), Liability Insurance (Combined Liability Policy) and Instructor Liability Insurance (Professional Indemnity Policy). For more details, search for the term 'Insurance' in the "Documents" tile on JustGo for the insurance documents for this year.
  
- *Q: Can anyone sign up to the Short-Term Membership?*
- A: The Short-Term Membership is available to adults (over 18 y.o.) who hold an existing diving qualification recognised by Diving Ireland in [DI 403 Diver Equivalency Application & Guide](#).
  
- *Q: How do I sign up? I've never used JustGo, can you help?*
- A: See detailed instructions below

- *Q: I am a PADI/SSI/BSAC/etc scuba diver with existing qualifications. Can I dive on a Diving Ireland club or event using this short-term membership?*
- A: Short-Term members must hold a Diving Ireland recognised diving qualification as recognised under the Diving Ireland Equivalence and Recognition policy IUC 403. See <https://sites.google.com/diving.ie/trainingdocuments/diver-equivalence> for more information. We strongly advise you to reach out to the Club DO well ahead of you planning to attend an event or dive here as the DO will need to complete the 'recognition' process and if applying for DI equivalence, the equivalence process does take time.
  
- *Q: What evidence do I need to provide to be able to scuba dive?*
- A:
  - Complete or provide documentary evidence of completion of the prescribed Fitness Test to the satisfaction of the Club Diving Officer (DO)
  - Provide evidence of Active Diver Status by way of a current dive log to the satisfaction of the Club DO
  - Apply for a Recognition Credential for a relevant non-Diving Ireland certifications and have the same approved by the Club DO. Short-Term members must hold a Diving Ireland recognised diving qualification as recognised under the Diving Ireland Equivalence and Recognition policy IUC 403.
  
- *Q: Are there any restrictions in the scuba diving I can do?*
- A: Short-Term members are not permitted to engage in any training, assessment or instructional activities. Short-Term members may not dive as a 'buddy' with any DI grade below D\*\*, i.e. no diving with D\* or novice divers. Short-Term members must only dive within the parameters of their existing diving qualifications and subject to the primacy of DI Training & Standards DI 401 parameters. See <https://sites.google.com/diving.ie/trainingdocuments/training/tands>
  
- *Q: Can I use the short-term membership to take an exam or to learn how to dive?*
- A: Short-Term members are not permitted to engage in any training, assessment or instructional activities.
  
- *Q: I joined as a short-term member last month and I am hooked! I want to join now full time; is there a discount?*
- Q: Yes, your Diving Ireland Short-Term Membership can be upgraded to a "Full Diver" annual membership through payment of an additional €100, if upgraded within 30 days of expiry of short-term membership. Conversion to full time membership at reduced cost of €100 is contingent on the applicant complying with and completing the Diving Ireland equivalence protocols IUC 403 and being issued a Diving Ireland certification – the cost of such certification is €30.

- *Q: I am a current Diving Ireland full member and I paid much more for my annual membership. Am I losing out by not choosing this short-term membership instead? Why should I pay for a more expensive annual membership if I could choose this cheaper short-term membership instead?*
- A: The short-term membership is intended for guests attending Diving Ireland events who are visiting but not usually based in Ireland and it's only valid for 30 days. It cannot be renewed or extended beyond that period. The Annual membership is designed for those who are going to be diving over a longer period of time (i.e. the spring and summer season) and are regular club members.
  
- *Q: I am a Club Administrator; what do I have to do? What are the benefits of this short-term membership to my Club? Can we/ should we charge a fee?*
- A: Short-term members will have to select a Club when signing up (see section "Choosing a Club" in the member instructions below). We are encouraging short-term members to reach out to the Club prior to applying for membership. As a Club Administrator, you will receive a notification to approve their request. We encourage you to reach out to the new member and welcome them to your Club. Diving Ireland are not prescribing whether you should charge Club Membership fees or not; it's up to you.
  
- *Q: I am a Club Diving Officer (DO); what do I have to do?*
- A: Like any other Member, their existing diving qualifications will need to be recognised by the Club DO before diving with Diving Ireland. Short-term members must complete or provide documentary evidence of completion of the prescribed Fitness Test to the satisfaction of the Club Diving Officer (DO). They must also provide evidence of Active Diver Status by way of a current dive log to the satisfaction of the Club DO. They must apply for a Recognition Credential for a relevant non-Diving Ireland certifications and have it approved by the Club DO. In summary, as Club DO, you must formally approve any recognition, fitness test and active diver status on the JustGo platform prior to the members engaging in any diving activity

Diving Ireland is now issuing digital membership cards to our short-term diver members.


Key benefits are:

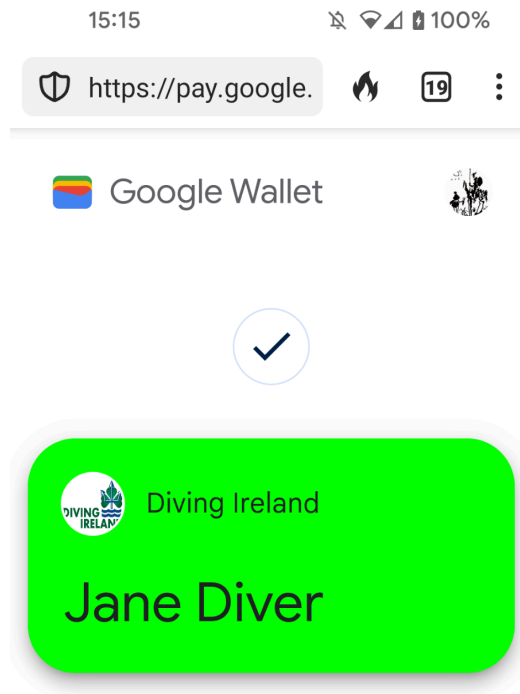

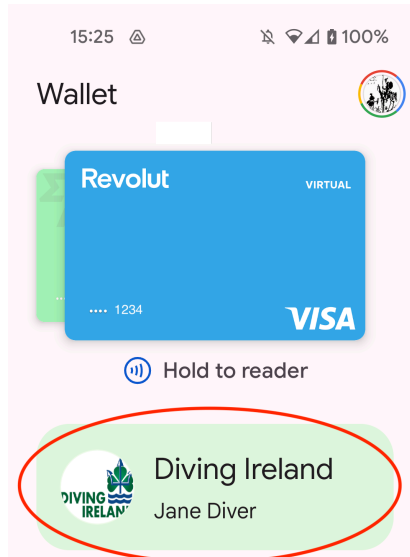

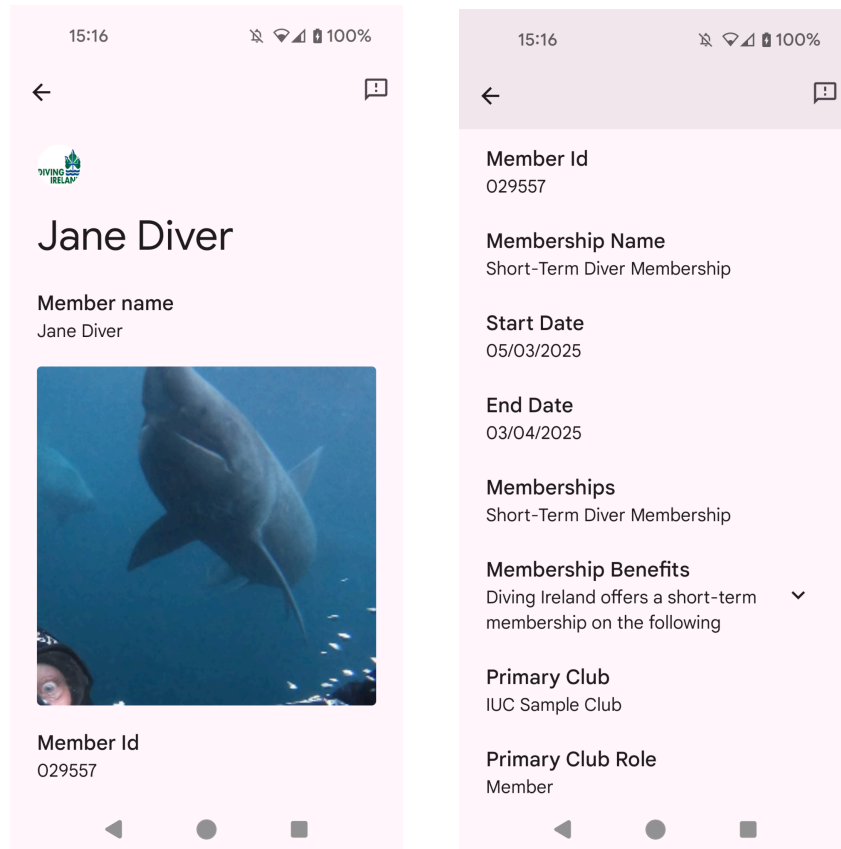
When you open the phone's wallet, in addition to any other cards you may have, you will see a new Diving Ireland card:

- Click on the three dots on top-right corner, or scroll to next page, to see your profile photo, member ID, membership name, start and end date, membership benefits, your club and club's role, etc



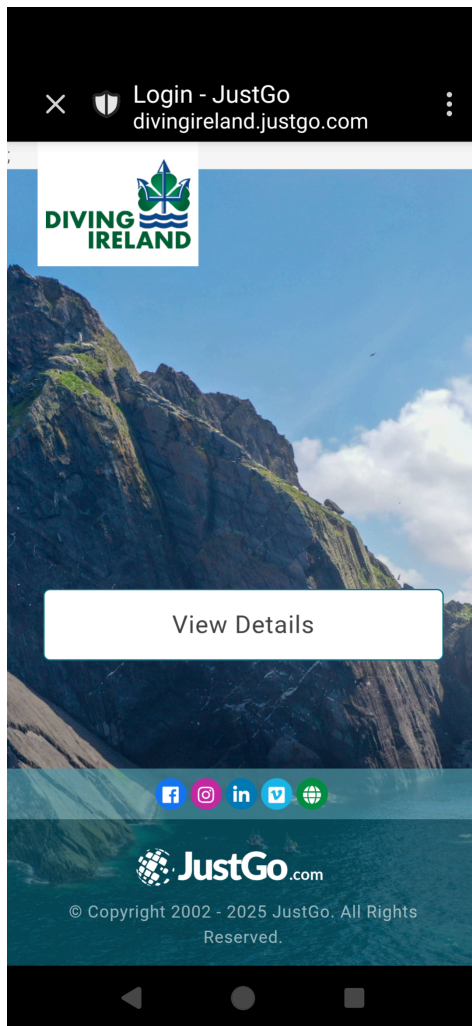
